2026 Rose Show: “For the Love of Roses”

Greater Palm Beach Rose Society

GENERAL RULES

A. This Rose Show is governed by the standard rules, regulations and guidelines of the American Rose Society (ARS).

1. Show Sponsorship, Management and Responsibility.

This show is produced and is the property of the Greater Palm Beach Rose Society (GPBRS). The Society provides all show management functions and establishes all show policies. The Greater Palm Beach Rose Society, Mounts Botanical Garden, or members of the Rose Show Committee are not responsible or liable for damage to any property or person.

2. What May be Exhibited. The show is designed for the display and exhibition of roses grown by the exhibitors in their private outdoor gardens. By entering this show the exhibitor attests that the roses entered were grown in their own outdoor garden. Generally, an exhibitor may enter more than one exhibit in a section providing no rose varieties are duplicated. Certain sections make an exception, as described in the show schedule.

3. Who May Exhibit. Competition is open to all rose growers, regardless of residence. Exhibitors may exhibit individually or as a family team of two from the same garden. By exhibiting in the show, the exhibitor agrees to abide by the rules of the show and conduct themselves in accordance with accepted standards for conducting rose shows.

4. **When to Submit Entries.** Entries are accepted from 7am-10am, Saturday, February 14, 2025. The exhibitor work area will be open at 6am. All entries will be placed by the exhibitor in the designated class for exhibition. All roses entered become the property of the GPBRS and may not be removed until after close of the show at 5pm, unless with the express permission of the Show Chairman. Photos entered for exhibition are the property of the exhibitor and must be picked up by the exhibitor, unless specified by the exhibitor that someone else will pick up their photo entries at 5pm. **Show awards and exhibitor-owned properties may be picked up Sunday at 3pm.**
5. **Containers.** GPBRS will provide all containers, except as indicated in the show schedule.
6. **Entry Tags.** Standard ARS entry tags, large and small, will be provided by the GPBRS and will be available in the work area. Small tags are used for all Miniature and Miniflora entries. The exhibitor must fill out the entry tag in its entirety and accepts responsibility for the accuracy and legibility of information he/she puts on the entry tags. The exhibitor must ensure the entry tag is folded appropriately to hide their personal information before placing the entry.
7. **Wedging Material.** The exhibitor may use whatever wedging material they want to wedge the rose stem, so long as the material is below the lip of the vase. Wedging material protruding above the lip of the vase is subject to penalization in judging.

8. **Varieties.** Only one entry of the same variety is allowed from the same garden in any one class, unless stated otherwise in this schedule.
9. **Sidebuds.** Specimens may be grown naturally with sidebuds, except where designated in the show schedule.
10. **Placement.** Exhibitors will place their own entries on the appropriate exhibition class table, as indicated on their entry tag.
11. **Judging.** Judging will begin at **10:15am**. No one will be allowed in the show area during judging except the judges, clerks, Show Chairman, Judges' Chairman and Clerks' Chairman, or anyone else authorized by the Show Chairman. Any questions or problems during judging will be resolved by the Show Chairman. Judges may grant or withhold awards at their discretion. The decision of the judges is final. All judges are accredited by the American Rose Society. Every attempt will be made to complete the judging by 1pm.

This show will be governed by the Guidelines and Rules for Judging Roses of the American Rose Society (ARS). Classification and eligibility will be determined in accordance with the latest editions of the Modern Roses, the Official List of Approved Exhibition Names for Exhibitors and Judges, the 2025 edition of Handbook for Selecting Roses, Modern Roses database online, and recent Rose Registrations on the ARS website.

In cases where a variety is not listed in any of the above ARS publications, the Combined Rose List (CRL) may be used as a reference.

12. **Exhibition Standards.** Judging is based on a comparison of a bloom's approach to perfection for the individual variety. At the time of judging, a rose should be at its **"most perfect phase of beauty,"** which is one-half to three-fourths open. The bloom should have a well-formed center, except for single or fully open specimens. Single and fully open specimens should be widely open and stamens showing. Stems should be fresh. Stem lengths should be in proportion to the size of the bloom. Foliage should be clean and free of spray residue.

13. **Disqualification Rules.**

- a. Foreign substance that has been applied to enhance the beauty of the rose entry.
- b. A misnamed specimen listed on the entry tag.
- c. An entry that is unlabeled, meaning lacking an entry tag, or that is mislabeled, meaning wrong information or lacking information for the exhibitor's name, class number or variety name on the entry tag.
- d. Exhibitor's name is visible, if not corrected before the entry is judged.

14. **Penalty Guidelines.**

- a. Stem on stem, to the degree of distraction, if any.
- b. Side buds can be penalized to the degree of distract, if any.

15. **Considerations.**

- a. Misplaced entries can be moved to the correct class before judging.
- b. Mislabeled entries with the wrong class on the entry tag can be moved to the correct class before judging.

17. **Awards.** First (blue), second (red), third (yellow), and fourth (white) place ribbons may be awarded in each class, if merited. Only blue ribbon winners will be considered for a class award on the trophy table. Judges may withhold any award they feel is not merited. The decision of the judges is final. The Queen, King and Princess for Hybrid Tea/Grandiflora will be selected from all blue ribbon winners in classes 20 and 39. The Queen, King and Princess for Miniature will be selected from all blue ribbon winners in class 33. The Queen, King and Princess for Minifloras will be selected from all blue ribbon winners in class 36. Judges will vote by written ballot on the Best of Show Award from all best-in-class winners. Photography classes are not eligible.

18. **Trophy Table.** Show winners for all classes will be moved to the tabulation table and then moved to the trophy table, where designated, by the clerks.

19. **Show Hours.** The Rose Show is open to the public from 1pm to 4pm on Saturday, February 14, and 9am-3pm on Sunday, February 15, 2026.



B. Horticultural Rules for Exhibition.

1. Containers and official ARS entry tags will be furnished by the Show Committee except where otherwise stated. Entry tags must be completed top and bottom by all exhibitors to include **class number, variety, name and address**. The reverse side may be used for listing variety names where space on the front is not adequate. All entries must be correctly named.
2. All entries will be placed by the exhibitor.
3. The use of wedge Styrofoam or other material is permitted to position a specimen in the container. The wedge, if used, should not extend above the top of the container.
4. Clusters or sprays must have two or more blooms. All climbing specimens or one-bloom-per-stem hybrid teas, grandifloras, and floribundas should be entered in the section for bush types of the same variety.
5. **Disqualification Rules.** Horticultural entries shall be disqualified (removed from judging consideration) for the following reasons:
 - a. **The presence of a foreign substance.** A foreign substance is anything that has been applied to the stem, foliage, and/or bloom to improve the appearance of the entry. As a general rule, an exhibitor may remove anything from an entry to improve its appearance but may not add anything.

- b. **Misnamed.** This refers to an entry that is not the variety named on the entry tag. It is the responsibility of the exhibitor to name varieties correctly.
- c. **Unlabeled or Mislabeled.** An unlabeled entry is an entry with no entry tag. A mislabeled entry is an entry that does not have the variety name, the exhibitor's name, and the class number on the entry tag.
- d. **Exhibitor's Name Visible During Judging.** An entry in which the exhibitor's name is visible during judging must be disqualified.
- e. **Roses not grown outdoors and/or not grown by the exhibitor.** Roses entered must be exhibitor grown.
- f. **Violation of the show rules**, as specified in the show schedule.

6. **Penalization Rules.** Horticultural entries shall be penalized for the following reasons:

- a. **Stem-on-stem.** This refers to an entry in which the stem has a portion of the previous stem attached and apparent above the lip of the vase. Stem-on-stem below the lip of the vase is irrelevant.
- b. **Side buds.** Potential penalization for side buds, if designated as not permitted.
- c. Any residue from horticultural sprays.
- d. A rose has been groomed in such a way that the variety's characteristics are grossly altered.
- e. Presence of one or two leaflets at the axil or an undeveloped stem.

- f. Points are deducted according to the degree of distraction; the more serious the fault, the greater the number of points deducted.
- 7. Misplaced entries should be moved to the correct section prior to the judging of that section.
- 8. Mislabeled entries with the wrong class on the entry tag should be moved to the correct class for judging.

C. Photography Rules for Exhibition.

- 1. All rose photos exhibited must have been grown in an outdoor garden. They do not have to be grown by the exhibitor. However, if the roses depicted in the photo are exhibitor grown, then "EG" must be written in the upper right corner of the entry tag.
- 2. All photos must be the work of the exhibitor only. A photo may NOT be entered more than once. Any photo entered must **not** be the same photo of a previous award winner, first through fourth place, at a previous ARS local or national rose show.
- 3. Photos in Classes 14, 15, 18 and 19 must be in color. Photos in Classes 16 or 17 may be color, black and white, sepia, or selective colorization (may use Photoshop™ type programs).
- 4. Use of Photo Editing Software. Any photo that utilizes photo editing software for any reason other than cropping, rotation, lightening, darkening, minor cleanup corrections for camera sensor dirt, or sharpening of the image should be severely penalized. Classes which require or

encourage the use of photo editing software for photo enhancement or creative interpretation will be immune to this penalization, as stated in the show schedule.

5. All rights to the photos entered belong to the exhibitor. However, the exhibitor warrants that he or she owns the copyright to the entered photo and is not the work of any other photographer.
6. Photos may not be removed until the close of the show.
7. All photos can be in any of the following size formats: 8" x 10", 5" x 7", 8" x 8", 6" x 6" glossy photographs, matted in any color matte, which will be provided by the exhibitor. Mattes may be 1.25-3" per side and single, double or triple matted photos are permitted. Photos can be exhibited either horizontally or vertically as the exhibitor chooses. This is intended to give the photographer the greatest flexibility in displaying their photos.
8. Entries must be received and entered at the Rose Show no later than 10:00am on the day of the show.
9. Your name and the name of the rose or name of the rose garden (if Class 18) must be entered on an official entry tag and clipped to the upper left of the matte, not blocking the view of the photo.
10. Number of photos entered in each photography class is restricted to 4 entries, but all photos must be different from any other by the same exhibitor.

11. The following is the scorecard for judging photographs:

Conformance	5 points
Specific Section	50 points
Composition	15 points
Technique	15 points
Distinction	<u>15 points</u>
Total	100 points

12. All photographs entered into an ARS sanctioned show, are the property of the photographer and are protected as intellectual property. No Society or Show Chair may retain photographs for the purpose of selling or raffling without the express written consent of the photographer. The exception to this rule is any photographs that are "abandoned" at the end of the show. This means the photographer has not claimed their work at the end of a show, and the Show Chair must clear the area. In this case, it is determined that the photographer is giving permission for the Show Chair to take possession of the photography exhibit.

Intellectual property rights are intangible rights protecting the products of human intelligence and creation, such as copyrightable works, patented inventions, trademarks, and trade secrets. Although largely governed by federal law, state law also governs some aspects of intellectual property.

ROSE SHOW SCHEDULE

DIVISION I

HORTICULTURE CHALLENGE CLASSES

Class 1. Cycle of Bloom

Three (3) specimens, Hybrid Tea or Grandiflora, of the same variety in three stages of opening. One bud with sepals down, one bloom at exhibition stage and one bloom fully open with stamens showing, in separate vases. Entry may be placed on the show table by the exhibitor.

Class 2. Reflections/Hi-Low

One (1) specimen, Hybrid Tea, Grandiflora or Floribunda and one (1) matching Miniature or Miniflora, each at exhibition stage or fully open in separate vases. Entry may be placed on the show table by the exhibitor. **ARS Certificate**

Class 3. Floating Hybrid Tea/Grandiflora Rose

One (1) specimen, Hybrid Tea or Grandiflora, bloom at exhibition stage, without stem or foliage, floating in an open bowl. Entry may be placed on the show table by the exhibitor. Only one entry per exhibitor allowed. **ARS Certificate**

Class 4. Floating Floribunda Rose

One (1) specimen, Floribunda, at exhibition stage, without stem or foliage, floating in an open bowl. Entry may be placed on the show table by the exhibitor. Only one entry per exhibitor allowed.

Class 5. Floating Hybrid Tea or Floribunda or Shrub or Old Garden Rose Collection

A collection of four (4) blooms, all one or more different varieties, at exhibition stage or fully open, without stem or foliage, floating in a large open bowl. Entry may be placed on the show table by the exhibitor. Only one entry per exhibitor is allowed.

**Rose bowls are limited in quantity. Consequently, they are furnished on a first come, first served basis.*

Class 6. Most Fragrant Modern Rose

Most fragrant rose, any variety classed as a Modern Rose.

ARS Certificate**Class 7. Most Fragrant Old Garden Rose**

Most fragrant rose, any variety classed as an Old Garden Rose.

ARS Certificate**Class 8. Hybrid Tea Bouquet**

Five (5) or more Hybrid Tea roses at exhibition stage, one or more varieties, in a single vase provided by the exhibitor, with one entry tag. Oasis may be used. List all varieties on the reverse of the entry tag.

Class 9. Floribunda Bouquet

Five (5) or more Floribunda roses, one or more varieties, in a single vase provided by the exhibitor, with one entry tag. Oasis may be used. List all varieties on the reverse of the entry tag.

Class 10. Miniflora or Miniature Bouquet

Five (5) or more Miniature or Miniflora roses, all one type, one or more varieties, in a single vase provided by the exhibitor, with one entry tag. Oasis may be used. List all varieties on the reverse of the entry tag.

Class 11. Old Garden Rose Bouquet

Five (5) or more Old Garden Roses, with or without sidebuds, one or more varieties, in a single vase provided by the exhibitor, with one entry tag. Oasis may be used. List all varieties on the reverse of the entry tag.

Class 12. Shrub Bouquet

Five (5) or more Shrub Roses, with or without side buds, one or more varieties, in a single vase provided by the exhibitor, with one entry tag. Oasis may be used. List all varieties on the reverse of the entry tag.

Class 13. Tin Can Mixed Bouquet

Five (5) or more roses, any type, with or without side buds, one or more varieties, in a single vase or tin can provided by the exhibitor, with one entry tag. Oasis may be used. List all varieties on the reverse of the entry tag, if known.

PHOTOGRAPHY CHALLENGE CLASSES**ARS Photography Certificate: Gold, Silver and Bronze****Class 14. One Rose Closeup**

One (1) rose, no side buds, any variety with an official ARS exhibition name.

Class 15. One Rose Spray

One (1) spray, no side buds, any variety with an official ARS exhibition name.

Class 16. One Rose Macro

Closeup of any combination of rose flower, stem and foliage, use of photography editing software permitted.

Class 17. Rose Creative Interpretation

One (1) rose, any variety, with exhibitor's own creative interpretation, use of photography editing software permitted.

Class 18. Rose Arrangement

One (1) arrangement of roses, any variety, including vase.

Class 19. Rose Garden

One (1) rose garden, private or public; if a public garden, exhibitor must include the name of the public garden.

Due to limited space, exhibitors are **limited to 4 photo entries in each photography class.*



DIVISION II**HORTICULTURE CLASSES****HYBRID TEAS AND GRANDIFLORAS**

**Class 20. One Hybrid Tea/Grandiflora Bloom Per Stem
(Exhibition Form)**

One (1) stem, exhibition stage bloom, no side buds. Exhibitors may submit as many entries as desired, but no duplicates. Entries in this class will be staged alphabetically by variety name. Eligible for **Queen, King, Princess**.

ARS Certificates: Gold, Silver and Bronze

**Class 21. One Hybrid Tea/Grandiflora Bloom Per Stem
(Decorative/English Style Form)**

One (1) stem, decorative or English style form, no side buds. Exhibitors may submit as many entries as desired, but no duplicates. Entries in this class will be staged alphabetically by variety name.

**Class 22. One Hybrid Tea/Grandiflora Fully Open
(Stamens showing)**

One (1) stem, one fully open variety, no side buds, with fresh stamens visible. Single types are excluded. Exhibitors may submit as many entries as desired, but no duplicates.

ARS Certificate

One (1) spray. Removal of spent blooms permitted.

One (1) specimen of an Old Garden Rose type introduced in 1867 or later. This includes roses without known dates but known to have existed in 1867 or later. **ARS Certificate**

MINIATURES

Class 33. One-Bloom-Per-Stem Miniature

One (1) specimen, exhibition stage, no side buds. Entries in this class will be staged alphabetically by variety name. Exhibitors may submit as many entries as desired but no duplicates. Eligible for **Miniature Queen, King and Princess** awards. **ARS Miniature Gold, Silver or Bronze Certificate**

Class 34. Fully Open

One (1) specimen, fully open with stamens showing, no side buds. No single type miniatures.

ARS Fully Open Miniature Certificate

Class 35. Single

One (1) specimen single type miniature, no side buds.

ARS Single Miniature Certificate

MINIFLORAS

Class 36. One Bloom Per Stem

One (1) specimen, exhibition stage, no side buds. Entries in this class will be staged alphabetically by variety name.

Exhibitors may submit as many entries as desired but no duplicates. Eligible for Miniflora **Queen, King and Princess**.

ARS Miniflora Gold, Silver or Bronze Certificate

Class 37. Fully Open

One (1) specimen, fully open with stamens showing, no side buds. No single type Minifloras.

ARS Miniflora Fully Open Certificate

Class 38. Single

One (1) specimen, single type Miniflora, no side buds.

ARS Single Miniflora Certificate

NOVICE

This section is open only to those exhibitors who have never won a blue ribbon in a rose show. Novices may compete in other sections of the rose show schedule.

Class 39. One-Bloom-Per-Stem Hybrid Tea or Grandiflora

One (1) specimen, exhibition stage or decorative type, no side buds. Exhibition stage blooms are eligible for **Queen, King or Princess. ARS Certificate**

Class 40. Floribunda Spray

One (1) specimen, spray of two or more blooms disbudded or naturally grown with side buds.

Class 41. Shrub Spray

One (1) specimen, spray of two or more blooms disbudded or naturally grown with side buds.

JUNIOR

This section is open only to exhibitors 17 years of age or younger.

Class 42. One-Bloom-Per-Stem Hybrid Tea/Grandiflora

One (1) specimen, exhibition stage or decorative type, no side buds. **ARS Certificate**

Class 43. Floribunda Spray

One (1) specimen, spray of two or more blooms, disbudded or naturally grown with side buds.

JUDGES

Open only to Judges working at this show. No limit on number of entries per class, so long as each entry is of a different variety.

Class 44. One-Bloom-Per-Stem (any variety).

One (1) stem, at exhibition stage.

Class 45. Spray (any variety).

One (1) spray of two or more blooms.
